INTRODUCTION TO THE NRF

The National Research Foundation Act, Act 23 of 1998, establishes the National Research Foundation ("NRF") as the juristic person that makes this bid invitation and will contract with the awarded bidder. The Public Finance Management Act classifies the organisation as a Schedule 3A Public Entity.

The NRF is the government's national agency responsible for promoting and supporting research and human capital development through funding, the provision of National Research Facilities and science outreach platforms and programs to the broader community in all fields of science and technology, including natural science, engineering, social science and humanities.

The **South African Institute for Aquatic Biodiversity (SAIAB)**, based in Makhanda formerly known as Grahamstown, Eastern Cape, is a **National Research Facility of the National Research Foundation**, a public entity, established in terms of the National Research Foundation Act No. 23 of 1998. SAIAB is an internationally recognised centre for the study of aquatic biodiversity.

CONTEXT OF THIS PROCUREMENT

The South African Institute for Aquatic Biodiversity is a biological sciences research Institute specialising in aquatic biodiversity, with a specific academic focus on fish (Ichthyology). NRF-SAIAB's research focuses on the full spectrum of aquatic environments, from marine offshore to continental freshwater catchments. Research covers ecology and conservation biology that links biodiversity at molecular and organism levels with the environment, genetic and species diversity. The Institute specialises in providing cutting-edge research infrastructure platforms for research in these various environments, and particularly in the marine field to develop the Biodiversity Economy and the Blue Economy, including the supervision of postgraduate students towards MSc and PhD qualifications.

As an innovative leader in aquatic biodiversity research, at the NRF-SAIAB, knowledge is our gold; it is the precious commodity that we mine and refine, through our support and advancement of scientific enquiry.

DETAILED SPECIFICATION

Specification of Goods / Works / Services being procured

The selected Graphic Designers will be responsible for providing creative design services to NRF-SAIAB on an as-needed basis. The scope of work includes but is not limited to:

- **Desktop publishing:** conceptualise, design and layout books, brochures, pamphlets, journal articles and other publications, promotional or display material and marketing collaterals for SAIAB as requested.
 - Developing infographics and illustrations, advertisements, graphs, maps and posters mostly of a scientific nature to SAIAB as requested.
 - Creating visually appealing graphics for social media campaigns.
 - Designing website layouts, icons, and user interfaces.
 - Providing photo editing and retouching services.
 - High resolution quality must be produced and, in the case of scientific journals, conform to specific formats required.
 - Ensuring brand consistency across all design projects.
 - Given the nature of the scientific work, there will need to be ongoing consultation between the designer and SAIAB to understand project requirements and deliver designs that meet the objectives to ensure accuracy.
- **Proofs to be supplied:** A reasonable amount of author's corrections (up to three rounds or three (3) hours) of proof corrections should be allowed and final proofs approved by SAIAB prior to final delivery.
- Timing: The timing required for the delivery of products will be negotiated with each order placed.
 - Most products need to be generated within a period of 20 working days although some products might need to be delivered within shorter time frames.
 - More complex/ larger products (e.g. books/ journals/ brochures) may require longer, but should be completed within three (3) months of receipt of order.
 - All products ordered must be delivered in full as per official order placed.

- 3 Software Maintenance Service: The contracted provider, during any paid software maintenance service term, provides software maintenance service for the licensed program(s) which consist of delivering subsequent releases of the program, if any; exerting reasonable efforts to both (a) provide, within a reasonable time, workarounds for any material programming errors in the current release of the program that are directly attributable to the contract provider, and (b) correct such errors in the next available release, provided the NRF provides the contract provider with sufficient information to identify the errors. The NRF, during the same paid software maintenance service term, is entitled to receive technical support for the current release. Technical support means assistance by telephone, fax, electronic mail, and any digital communication methods with the installation and/or use of the then-current release of the licensed program, including all available bug fixes and patches, and their interaction with the supported hardware and operating systems ("Platforms").
- 4 <u>**Contracted Party Due Diligence:**</u> The NRF has the right to conduct supply chain due diligence including site visits and inspections at any time during the contract period.
